

REQUIREMENTS FOR ADMISSIONS -- ARTICLE II, SECTION 1, BY-LAWS

ADMISSION

- (a) Membership shall be by invitation only. Each application for membership shall be endorsed by two members. Applicants shall furnish with each application evidence of the ownership of or a binding contract for the acquisition of one share of stock in the Club if required.
- (b) The application must be accompanied by the membership fee in force at the time of the application, one month's dues and the food and beverage minimum. Please make check payable to East Ridge Country Club. The application is submitted to the membership chairman for review, upon approval, the applicant's name, address, occupation and names of members recommending him is posted on the Bulletin Board in the Clubhouse for 15 days, before the membership is final. Two (2) negative votes of the Screening Committee shall be sufficient to cause the rejection of such application.
